<b>Note 1</b>	<b>Anti-Doping Organisation</b> Specify the name of the anti-doping organisation (ADO) to which you have previously submitted a TUE request. The ADO may be FIFA or your national anti-doping organisation, which could be either your national Olympic committee or another designated body.
	<b>FA Chief Medical Officer</b> Where possible, the Chief Medical Officer (CMO) of your national football association should be notified of your TUE application to UEFA. When appropriate, the application should include a statement from the CMO attesting to the necessity of the otherwise prohibited substance or prohibited method in the treatment of the player.
