NEXT STEPS FOR THE WORKING GROUP

Extracts from the minutes of the 8th meeting, 3 December 2009

It was agreed that:

- (1) The draft Minutes and draft Internet Report would be circulated according to the usual procedure.
- (2) The WG would have its 9th meeting on **Wednesday, 30 June 2010.**
- (3) Work on the Implementation Table relating to the EU Physical Activity Guidelines would proceed as agreed (see above) with AT, ES, FR, EOC, ENGSO acting as volunteers who would send their first trial replies by 1 February 2010 and COM sending out a revised questionnaire by 1 March 2010.
- (4) Based on the revised questionnaire, COM would ask all other WG members for input by May, in time for a discussion at the next meeting.
- (5) COM would report on the outcome of the 8th WG meeting to the meeting of EU Sport Directors (Barcelona, 25-26 February).
